- 2. The Court is aware that Mr. Bent has medical problems and directs the Union County Sheriff's Office to utilize the services of an ambulance or EMT's for the transport of Mr. Bent in a manner consistent with guarding his health and well-being.
- Mr. Bent shall be first transported to the Union County General Hospital for a medical appraisal. If Mr. Bent is determined to be in good enough health for incarceration he shall be held in the Union County Detention Facility until further order of this Court.
- 4. If Mr. Bent is determined not to be in good enough heath for incarceration, he shall be maintained at the Union County General Hospital for such a time as medical personnel deem that he can be transported to detention facilities and shall remain, during this period of medial assistance, under the custody,
