ARREST AND PICKUP ORDER

10 **THIS MATTER** having come before the Court on October 30, 2008, for a status conference
11 with regard to the Supplemental Juror Questionnaires to indicate that a Change of Venue was
12 indicated. The Defendant, Wayne Bent, having failed to appear in violation of conditions of release
13 for having failed to appear after receiving proper notice of the above referenced hearing.

14 **THEREFORE** this Court hereby **ORDERS**:

- 15 1. The Union County Sheriff's Office travel to Strong City and pick up Mr. Bent
16 to be placed in custody, pending further action in this matter.
- 17 2. The Court is aware that Mr. Bent has medical problems and directs the Union
18 County Sheriff's Office to utilize the services of an ambulance or EMT's for
19 the transport of Mr. Bent in a manner consistent with guarding his health and
20 well-being.
- 21 3. Mr. Bent shall be first transported to the Union County General Hospital for
22 a medical appraisal *as to his physical & psychological well-being*. If Mr. Bent is determined to be in good enough health
23 for incarceration he shall be held in the Union County Detention Facility until
24 further order of this Court.
- 25 4. If Mr. Bent is determined not to be in good enough health for incarceration,
26 he shall be maintained at the Union County General Hospital for such a time
27 as medical personnel deem that he can be transported to detention facilities
28 and shall remain, during this period of medial assistance, under the custody,
