R.E. State of New Mexico vs. Wayne Bent AKA Michael Trammer

Dear Sir:

For the past several months, witnessing at Michael's trial has been weighing heavy on my heart. Mr. Benavidez, it's not that I don't want to or that I won't; it's that I can't. It is surely against my conscience and religious beliefs. I can't participate in something I don't agree with and that is against my conscience and religious beliefs. Therefore, I would kindly ask of you, please grant my request, and if you're not the person I should be asking, will you please direct me to that person. Thank you!

There is one more thing on my heart to say. When Michael's attorney, Sarah Montoya, interviewed me with you and Dave O'Bryan present, she asked me if when Michael laid his chest on mine, if he touched my breasts or if there was anything in between. I told her yes, and that there was nothing in between us, but inside I felt unashamed because I could not remember Michael touching my breasts ever at anytime. But I thought he must have if he laid on me the way I remembered he did, so I told Ms. Montoya that he did touch my breasts.
